

Open Community Support Groups from Charlie Health

Youth Assessment Centers

In Spring 2022, the Idaho Legislature appropriated the Idaho Department of Juvenile Corrections \$6.5 million to establish Youth Assessment Centers across Idaho. IDJC partnered with the National Assessment Center Association to provide Assessment Center 101 training in Idaho and develop a competitive grant process. Through that process, eight Assessment Center grants were awarded across each judicial district in Idaho. The projects started on July 1, 20222 and as of 12.13.22, four assessment centers are open and serving youth in their communities and four projects are in varying states of implementation. The project period will end June 30, 2023. Stay tuned for updates regarding this exciting work and contact Holly Walund, IDJC Project Manager for additional information.

Youth Behavioral Health Community Crisis Centers

Also in spring 2022, the Idaho Legislature appropriated IDJC \$4.4 million to establish youth crisis centers in Idaho in collaboration with the Idaho Department of Health and Welfare. IDJC and IDHW collaborated to release a grant on September 30, 2022. We received 7 applications, spanning 6 of the 7 judicial districts across Idaho. In December, four YBHCCC grant awards were accepted and YBHCCCs will be coming in Districts 3, 4, 5 and 7.
